NOTICE OF INTENT

It is the intent of the Rialto Unified School District, Child Nutrition, to award a contract as a result of this Request for Proposals (RFP). Products and/or services considered for award shall equal or exceed a minimum quality level of industry standards as defined within this RFP, and shall comply with all applicable federal, state, and local technical, environmental, and performance standards and specifications.

<u>DEFINITIONS</u>: In this RFP and in the Contract, the following terms are defined as follows:

- A. "Best Value" means the method by which a Contract, if any, is awarded, in accordance with applicable laws, rules, and regulations. Best Value includes multiple parameters, including experience, references, quality of Vendor's product(s) and/or services, and price.
- B. "Contract" means an agreement entered into between the District and a Vendor as a result of this RFP. The Contract consists of the Request for Proposals, including all Addenda, Vendor's Proposal that is satisfactory to the District, and the District's Contract form(s), which may include, but are not limited to, a written contract, an agreement letter, or a purchase order.
- C. "Proposer/Bidder" refers to the person/firm that submits Proposal in response to this RFP.
- D. "Project" means the Scope of Work for furnishing goods and services as outlined in this RFP.
- E. "Proposal" refers to the documents submitted by a Proposer that addresses the scope and requirements of this RFP.
- F. "RFP" refers to this Request for Proposals.
- G. "Responsible Vendor" means a vendor with adequate financial resources (or the ability to obtain such resources), who can comply with the delivery requirements, and who is a qualified and established firm regularly engaged in the type of business that provides the goods and/or services herein.
- H. "Responsive Proposal" refers only to those proposals that comply with all material and administrative aspects of this RFP.
- I. "District, and/or government entity" refers to Rialto USD Child Nutrition.
- J. "Vendor" refers to the person(s)/entity (ies) that submits the Proposal to whom a Contract is awarded pursuant to this RFP.
- K. Singular terms shall include the plural and vice versa. A gender reference includes both genders.

INSTRUCTIONS & INFORMATION FOR PROPOSERS

1. PREPARATION AND SUBMISSION OF PROPOSAL:

Rialto Unified School District Child Nutrition, invites proposals on the forms enclosed to be submitted no later than 9:00 AM on Monday, April 14, 2025. All blanks on the proposal forms must be appropriately completed. Each Proposal must be submitted in a separate sealed envelope bearing on the outside "RFP No. RIANS-2025-2026-001 DAIRY AND OTHER RELATED PRODUCTS." It is the sole responsibility of the Proposer to ensure that the Proposal is received by 9:00 AM on Monday, April 14, 2025. Any Proposal received after the scheduled closing time for receipt of proposals will be returned to the Proposer unopened.

2. PROPOSAL OPENING:

All proposals shall be publicly opened at 9:00 AM on Monday, April 14, 2025, at:

3. SIGNATURES:

Rialto USD Child Nutrition will not accept a Proposal if a document requiring an officer's signature is not signed by one of the above individuals.

- 4. MODIFICATIONS AND CORRECTIONS: Changes in or additions to the Proposal or the Excel Pricing Spreadsheet, alternate proposals, or any other modifications of the proposal form which is not specifically called for in the proposal documents may result in rejection of Proposal as not being responsive to the invitation to proposal. No oral or written modifications of any proposal submitted will be considered. Proposals should be verified before submission and cannot be withdrawn after their opening.
- 5. ERASURES, INCONSISTENT OR ILLEGIBLE BIDS: The Proposal submitted must not contain any erasures, interlineations, or other corrections unless each such correction is suitably authenticated by affixing in the margin immediately opposite the correction the surname or surnames of the persons signing the Proposal. In the event of inconsistency between words and figures in the proposed price, words shall control figures. In the event that the District determines that any Proposal is unintelligible, inconsistent or ambiguous, the District may reject such Proposal as not being responsive to the RFP.

- 6. <u>ADDENDA/CLARIFICATIONS</u>: Rialto Unified School District, Child Nutrition reserves the right to revise any part of this RFP, or to provide clarification or additional information after the RFP documents are released. Each recipient of the packet will be notified by email, which will include a written addendum. Recipients of record are those parties, which obtained a copy of the packet directly from Rialto Unified School District, Child Nutrition. It shall be the responsibility of the Bidder's to inquire of Rialto USD Child Nutrition as to any addenda issued. This may be done via email (<u>Mrangel@rialtousd.org</u> cc: <u>Wvelasco@rialtousd.org</u>) prior to the proposal submittal deadline. All addenda issued shall become part of the RFP.
- 7. <u>WITHDRAWAL OF PROPOSAL</u>: Any Proposer may withdraw its Proposal personally or by written request at any time prior to the scheduled closing time for the receipt of proposals.
- 8. <u>INTERPRETATION OF PROPOSAL DOCUMENTS:</u> If any Proposer finds discrepancies in, or omissions from, the RFP or proposal documents, they may submit to the Lead Nutrition Services Agent of the Rialto Unified School District, Child Nutrition a written request for clarification, and the response thereto will be sent to all Proposers. Corrections will be made by addenda issued to each company that has been sent or picked up a proposal packet. District will not be responsible for oral interpretations. All addenda issued during the time of bidding shall be incorporated into the Proposal.
- 9. PROPOSAL DOCUMENT: The complete Proposal shall include the following documents: Notice Inviting Proposals, Instructions to Proposers, General Conditions, Non-Collusion Declaration, Proposal Form, hard copy of Price Pricing Spreadsheet, Electronic Media (USB drive) of Pricing Spreadsheet, Proposer Criteria Form, Disclosure of Lobbying Form, Certification Regarding Lobbying Form, Suspension and Debarment Certification Form, Health Department Inspection Reminder, Certification for "Buy American" Provision, and Vendor Questionnaire. Any of these shall be interpreted to include all the provisions of the other documents as though fully set out therein. The Proposer should fully acquaint themselves with the conditions and terms affecting the performance of the Contract if awarded. The Proposer's submission of a Proposal shall be taken as prima facie evidence of compliance with this section. Proposals should be verified before submission, as they cannot be withdrawn after their opening.
- 10. <u>CONTRACT PERIOD</u>: It is anticipated that the Agreement to be awarded under this Proposal shall be effective July 1, 2025 through June 30, 2026. Prices must remain firm until December 31, 2025.
- 11. PRICES: Submit price on each line item separately. All prices must be firm from July 1, 2025 through December 31, 2025. Rialto USD Child Nutrition may allow ONE price increase after December 31, 2025, with a thirty (30) calendar day written notice. However, price increase may be allowed based on the percentage of price increase for products that are at or below the consumer price increases for "All Urban Consumers" Database Series for the statistical area of "US City Average" from the category "Food Away From Home" as listed on the Bureau of Labor Statistics (BLS) web site. The Vendor may use the preceding six (6) months, March to September. Vendor may provide alternate documentation if BLS data is not available. Acceptability of alternate documentation is at the discretion of Rialto Unified School District, Child Nutrition. Absolutely no fuel surcharges may be levied during the term of the Contract.

- 12. <u>EVIDENCE OF RESPONSIBILITY:</u> Upon request of the group, a Proposer whose Proposal is under consideration for award shall promptly submit satisfactory evidence showing its financial resources. Rialto Unified School District, Child Nutrition requires the name of five (5) references for whom similar supplies or equipment were provided during the previous year.
- 13. <u>TAXES:</u> Rialto Unified School District, Child Nutrition will pay for state and local taxes. Do not include taxes on the proposal form.
- 14. <u>DELIVERY:</u> All prices shall be quoted as FOB destination. Destination shall be the Rialto USD School Site placing the order. No additional fees shall be charged for small orders. All shipments shall be accompanied by a delivery receipt. Purchase order number shall appear on all delivery receipts and invoices. All costs for delivery, drayage, insurance, freight, or the packing of the said articles is to be borne by the Vendor. Deliveries will be made by appointment only when requested. DELIVERIES REQUESTED BY APPOINTMENT ONLY AND NOT DELIVERED BY APPOINTMENT WILL BE SUBJECT TO REJECTION. The above listed information is to be reproduced on the Vendor's Bill of Lading. Vendor will be responsible for all accessorial charges associated with the shipping of goods ordered due to failure to follow above listed shipping instructions. Returns of non-quality/damaged goods must be picked up by the Vendor.
- 15. <u>COMMENCEMENT OF DELIVERIES</u>: After receiving written notification of award, each successful Proposer shall be required to commence with the delivery of all items, which have been awarded immediately after receipt of a purchase order. Failure to complete all deliveries within fourteen (14) calendar days after receipt of a purchase order shall be considered sufficient cause for default action under the DEFAULT provision of this Proposal.
- 16. <u>WARRANTY OF QUALITY:</u> The Vendor, manufacturer, or his assigned agent shall guarantee the food products against all defects.
 - (a) Cases and packaging shall be constructed to ensure safe and sanitary transportation to the point of delivery. Damaged cases or packages may be rejected and returned for credit or immediate replacement at no cost to the District.
 - (b) All products delivered shall be delivered in fresh form, with adequate shelf life, no less than two (2) weeks from the expiration date.
 - (c) The District reserves the right to discontinue service of any or all portion of any Contract resulting from this Proposal for any reason determined by the District to be detrimental to the health and welfare of the students and school personnel, or failure to meet contract specifications or wholesomeness standards, and to hold the Vendor in default.
- 17. <u>INSPECTION OF FACILITIES EVALUATION:</u> The District reserves the right to inspect the facilities of the Proposer prior to award of the Contract. The District may request to review the Proposer's current Hazard Analysis Critical Control Points (HACCP) food safety system for their facility in order to ensure optimum storage and distribution practices. If the District determines that after such inspection the Proposer is not capable of performing within the District's standards, their Proposal will not be considered. The findings and decisions of the District shall be final.
- 18. <u>PRODUCT QUALITY CONTROL:</u> Rialto USD Child Nutrition reserves the right to discontinue service of all or any portion of any contract resulting from this proposal for any reason determined

by Rialto USD Child Nutrition to be detrimental to the health and welfare of the students and school personnel, or failure to meet contract specifications or wholesomeness standard, and to hold the contractor in default. All products received under this contract shall be processed according to the health and sanitation standards for plant facilities and food processing established by the locality or state in which Vendor's plant is located or by the applicable federal standards, whichever is higher. Vendor shall provide products from manufacturers with a Hazard Analysis Critical Control Point (HACCP) system in place. Additionally, Vendor shall ensure that all products received under this contract shall be prepared, handled and are stored in accordance with the health and sanitation standards for the County of San Bernardino or local city/county agency in which product was produced, State of California, and/or Federal Government, whichever is higher. Vendor shall follow appropriate procedures for the First in First out (FIFO) stock rotation system. Products received shall not have a shelf life or expiration date less than one month from the date of delivery. Vendor shall follow appropriate handling and storage practices; this will include providing proof of established sanitation procedures and an active pest control program to assure proper information. In the event of a product contamination issue, Vendor shall provide trace back capabilities for all products to the point of origin.

Evidence of such procedures should be submitted with proposal:

- a. HACCP Plan
- b. Food Safety and Security Plan
- c. Pest Control Policy
- 19. <u>HEALTH INSPECTION:</u> The Vendor must include a copy of the most recent Environmental Health Official Inspection Report of all operating facilities with the bid package.
- 20. <u>NUTRITIONAL INFORMATION AND LABELING:</u> In order to accommodate the computerized menu system utilized by Rialto USD Nutrition Services, the successful Vendor shall be required to provide a complete nutrient analysis of some products, as requested by the District. The nutrient information may be obtained from an independent laboratory. The following information will be required from the manufacturer: weight (gm), calories (Kcal), protein (gm), carbohydrate (gm), fat (gm), polyunsaturated fat (gm), saturated fat (gm), trans fat (gm), sodium (mg), cholesterol (mg), dietary fiber (gm), vitamin A (IU), vitamin C (mg), calcium (mg), and iron (mg).
- 21. ALL PROCESSED FOODS SHOULD NOT CONTAIN ANY ARTIFICIAL TRANS FAT: All ingredients must be declared on the product label and conform to the Food Allergen Labeling and Consumer Protection Act as required by the Food and Drug Administration. Labels must list the presence of the ingredients which contain: protein derived from milk, eggs, fish, crustacean shellfish, tree nuts, peanuts, wheat, or soybeans. Distributor shall notify the District whenever there is a product/ingredient change in any item provided to the District. If any product changes occur, new ingredient statements and nutritional information shall be provided to the District's Food Services Department.
- 22. <u>FOOD DEFENSE</u>: Proposer's distribution facility must be registered with the Food and Drug Administration and meet the requirements of the Food Safety Modernization Act (FSMA). For further information, visit the FDA's official site at

http://www.fda.gov/Food/GuidanceRegulation/FSMA/default.htm. Failure to register prior to close of Proposal may result in the Proposer's disqualification for Contract award.

- 23. <u>SAFETY AND SANITATION:</u> Food Services staff will only receive product that meets all food safety and sanitation requirements, therefore Food Services staff may at any time:
 - Inspect delivery trucks for any signs of contamination.
 - Check all expiration and best if used by dates.
 - Use thermometers to check temperatures.
 - Accept products only at acceptable temperatures.
 - Reject unacceptable items.
- 24. QUANTITIES: Quantities shown are estimated usage of Rialto USD Child Nutrition for the proposal period. The District reserves the right to purchase more or less of the units specified. Rialto USD will order in quantities best suited to their needs and storage facilities. Price proposal shall be firm for the District and shall not increase or include shipping or any additional handling fees for districts ordering in small quantities. (These quantities are not guaranteed by the District but are included for information.)
- 25. <u>SAMPLES</u>: Rialto Unified School District, Child Nutrition has the right to request samples of items prior to the award. If the Proposer is bidding items/brands other than those specified or where no brand is indicated in the proposal document, the following shall apply: Samples may be requested prior to the award of line items. Bidder will be contacted to request specific line items. All items are to be labeled with the RFP number, line item, and the name and contact information of Bidder providing samples. If this information is not provided, the sample may be rejected and the Bidder disqualified from the award.

- A. Samples must be submitted free of charge. Samples must be clearly marked as to which Bidder they belong to.
- B. All packages containing samples must be clearly labeled "RFP No. RIANS-2025-2026-001 DAIRY AND RELATED PRODUCTS" and each sample clearly identified as to the bid and item numbers under which it is to be considered.
- C. Samples that do not comply with these instructions shall not be considered for award.
- D. All samples become the property of the district unless otherwise agreed to between the District and the Bidder.
- **26. BRANDS, SIMILAR PRODUCTS, "Or Equal":** Whenever Rialto USD Child Nutrition refers to a product by describing a proprietary product or by using the name of a manufacturer or brand name, the term "or equal" if not inserted shall be implied, as applicable. The specified product shall be understood as indicating type, function, minimum standard of design, efficiency, and quality desired, and shall not

be construed as to exclude other manufactured products or comparable quality, design, and efficiency, as applicable.

- 27. PRODUCT RECALLS: If a product recall is instituted on an item that has been furnished and delivered to Rialto Unified School District, Vendor must immediately notify Rialto USD Child Nutrition with all pertinent information regarding the recall.
- 28. <u>CREDIT MEMOS</u>: The Vendor's delivery driver shall provide delivery site with a credit at the time of delivery for all merchandise short on delivery, or damaged or spoiled product necessitating a return or reorder. A copy of this credit, price and extended, shall be mailed or emailed with the corresponding invoice to the Rialto USD Child Nutrition accounts payable employee.
- 29. TERMINATION OF AGREEMENT WITHOUT CAUSE: Rialto Unified School District may terminate this Agreement at any time by giving the Contractor thirty (30) days written notice of such termination. Termination shall have no effect upon the rights and obligations of the parties arising out of any transaction occurring prior to the effective date of such termination. Other than payments for goods or services satisfactorily rendered prior to the effective date of said termination, Vendor shall be entitled to no further compensation or payment of any type from the District.
- 30. <u>DISTRICT'S RIGHT TO WITHHOLD CERTAIN AMOUNTS AND MAKE APPLICATION</u>

 <u>THEREOF:</u> The District may withhold a sufficient amount or amounts of any payment otherwise due to the Vendor, as in its judgment may be necessary to cover defective items not remedied, and the District may apply such withheld amount or amounts to the payment of such claims, at its discretion.
- 31. <u>MULTI-YEAR EXTENSIONS</u>: Subject to the provisions of pricing-terms of contract, and pursuant to Education Code, Section 17596, this Proposal may be extended (by mutual consent expressed in writing) for two (2) additional fiscal school years.

The extension may be granted on a year-by-year basis provided that the following conditions are being met:

- A. Rialto USD Child Nutrition has deemed the products and services of the vendor satisfactory.
- B. The Vendor shall submit a list of the price increases for the next fiscal year (July 1 to June 30) by the last business day in April 2026.
- C. The percentage of price increase for products are at or below the consumer price increase for "All Urban Consumers" Database Series for the statistical area of "US City Average" from the category "Food Away From Home" as listed on the Bureau of Labor Statistics (BLS) web site (http://www.bls.gov/data/). The Vendor may use the preceding twelve (12) months April to March, depending on the most recent months listed on the website two weeks prior to submittal of price increases. Vendor may provide alternate documentation if BLS data is not available. Acceptability of alternate documentation is at the discretion of Rialto USD Child Nutrition.
- D. If prices were increased midyear (see Instructions & Information for Proposers, Item #11) the total increase in contract prices (July to June) shall not exceed item "C" listed above.
- E. Documentation of Insurance Coverage, (General Conditions, Item #12) shall be resubmitted with each request for contract extension.

F. Additional Items: Additional items may be added to the Extension Proposal, not to exceed ten percent (10%) of the value of the award. The District shall contact the successful Bidder for pricing on additional items to be added to the Proposed Extension award at any time during the bid period.

32. PROPOSAL FORM DIRECTIONS:

- A. Proposer shall download the Excel Pricing Spreadsheet template provided in requesting email or from flash drive accompanying the proposal documents.
- B. Proposer shall enter the brand/trade name and the manufacturer and vendor stock keeping unit (SKU) numbers in appropriate columns of Excel Pricing Spreadsheet. When one or more items are co-specified by District, stating "as specified" will not satisfy this requirement.
- C. If Distributor's SKU is different or unique as compared to the manufacturer's SKU, Distributor's SKU must be entered in the appropriate column.

- J. Whenever the specification notes "only," this requirement is made in order for the District to match existing supplies and equipment or because no other equal is known to exist. Proposer may submit "equal" products in accordance with the sample provision of Paragraph 25 of the "Instructions to Proposer."
- K. The District reserves the right to purchase additional units, at various quantities, under the terms and conditions provided in this Proposal. Proposers are to submit the unit price for each item, reflecting any quantity breaks in a separate column of the spreadsheet. Proposers are to enter this information in the last column provided. A single unit price submitted on the proposal response form shall be interpreted to be the price for any quantity ordered.

- L. The District reserves the right to reject any or all proposals, in whole or in part, and to be the sole judge of the merits and qualifications of all proposals and the products submitted as "equal" to the District's specifications and not necessarily accept the lowest price offered.
- M. The District reserves the right to reject proposals with multiple items per line item. Proposers submitting proposals with more than one item per line item may be rejected on grounds of non-responsiveness or non-responsibility.
- 33. <u>BID PROTESTS PROCEDURES:</u> Any Proposer may file a bid protest. The protest shall be filed in writing with the Lead Nutrition Services Agent not more than five (5) business days after the date of the bid opening. An e-mail address shall be provided and by filing the protest, protesting Proposer consents to receipt of email notices for purposes of the protest and protest related questions and protest appeal, if applicable. The protest shall specify the reasons and facts upon which the protest is based.
 - A. Resolution of Bid Controversy: Once the bid protest is received, the apparent lowest responsible Proposer will be notified of the protest and the evidence presented. If appropriate, the apparent low Proposer will be given an opportunity to rebut the evidence and present evidence that the apparent low Proposer should be allowed to perform the work. If deemed appropriate by the District, an informal hearing will be held. The District will issue a written decision within fifteen (15) calendar days of receipt of the protest, unless factors beyond the District's reasonable control prevent such resolution. The decision on the bid protest will be copied to all parties involved in the protest.
 - B. <u>Appeal</u>: If the protesting Proposer or the apparent low Proposer is not satisfied with the decision, the matter may be appealed to the Lead Business Services Agent or their designee within three (3) business days after receipt of the District's written decision on the bid protest. The appeal must be in writing and sent via overnight registered mail with all accompanying information relied upon for the appeal and an e-mail address from which questions and responses may be provided to:

- C. <u>Appeal Review</u>: The Lead Business Services Agent or their designee shall review the decision on the bid protest from the Lead Nutrition Services Agent and issue a written response to the appeal, or if appropriate, appoint a Hearing Office to conduct a hearing and issue a written decision. The written decision of the Lead Nutrition Services Agent or the Hearing Officer shall be rendered within fifteen (15) calendar days and shall state the basis for the decision. The decision concerning the appeal will be final and not subject to any further appeals.
- 34. <u>COURIER DELIVERIES</u>: It is each Proposer's sole responsibility to ensure its Proposal is timely delivered and received at the location designated as specified above. Any proposal received at the designated location after the scheduled closing time for receipt of proposals shall be returned to the Proposer unopened. The District is not responsible for proposals sent via U.S. Mail, UPS, and

Federal Express, or by any other delivery service. All proposals are due in the Nutrition Services Department by the posted or advertised closing date and time. It is the Proposers' responsibility to ensure that their Proposal is delivered to the Rialto Unified School District located at 151 S. Cactus Ave. Rialto, CA 92376

35. **BUY AMERICAN PROVISION:** Federal regulations require that to the maximum extent possible. only domestic products are to be purchased consistent with the "Buy American" provisions of Public Law (P.L.) 105-336 under the Richard B. Russell National School Lunch Act. Manufactured end products must be manufactured in the United States. Any product processed must contain over 51% of the product's food component, by weight or volume, from U.S. origin. This definition of domestic product serves both the needs of schools and American agriculture. Nutrition labels should include the country of origin for both domestic and imported food products. 1. <u>AWARD OF CONTRACT:</u> The District reserves the right to reject any or all proposals, or to waive any irregularities or informalities in any proposals or the bidding, and to make its selection of items awarded based upon its specifications, or which are most economical and/or best suited for the purpose of acceptance for sixty (60) calendar days after the proposal opening date. The District reserves the right to award to one or more Proposers.

The District reserves the right to be the sole judge of the merits and qualifications of all proposals and the products submitted as "equal" to the District's specifications and not necessarily accept the lowest price offered.

It is the intention of Rialto USD Child Nutrition to select the items to be purchased on an item-byitem basis wherever practical. However, the District reserves the right to combine items of like design and/or type to maintain uniformity.

The District further reserves the right not to necessarily purchase all items and/or quantities listed in the proposal documents. The quantities listed are estimates of the needs of the District and may be adjusted to meet the actual needs, when determined.

2. PRICES: All prices must be firm from July 1, 2025 through June 30, 2026.

Prices for Class 1, 2, and 3 products and orange juice may be adjusted during the contract period. Adjustments, either upward or downward, will coincide with the release of the State of California, Department of Food and Agriculture, Announcement of Minimum Prices for Market Milk. All notifications of price adjustments must be made in writing by the Contractor and received by the Lead Nutrition Service Agent at least <u>five (5) working days prior to the effective date of the adjustment.</u>

Class 1 Fluid Milk Products:

Prices for Class 1 fluid milk products will be adjusted based on the <u>Announcement of Minimum Prices for Class 1 Market Milk</u> released by the Dairy Marketing Branch of the State of California, Department of Food and Agriculture, at http://www.cdfa.ca.gov/dairy.

Class 2 and 3 Dairy Products:

Prices for Class 2 and 3 dairy products may be adjusted based on the <u>Announcement of Minimum Prices for Market Milk</u>, as referenced above, based on changes in the class 4a market.

Orange Juice:

The District will adjust the price of orange juice according to the prices shown as <u>Future Prices</u>, listed as Orange Juice (CTN), as published in the Wall Street Journal. Formula for calculation will reference 1.029 lbs. of solids per single strength juice at 11.8 degree Brix. The base price shall be the price as of the closing date of this bid.

3. <u>PLACEMENT OF ORDERS & LEAD TIME:</u> Orders shall be issued directly to the Vendor by Rialto Unified School District Child Nutrition, or one of the school sites, commencing from the award

- of contract (July 1, 2025 through June 30, 2026). Ordering and lead time procedures will be mutually agreed upon between Vendor and Rialto USD Child Nutrition, but **not to exceed 14 calendar days.**
- 4. <u>SUBSTITUTIONS</u>: Substitutions for awarded items must be pre-approved in writing by Rialto USD Child Nutrition and delivered at or below awarded price. Items must be of same or better quality and meet reimbursable meal requirements. Additional costs if any will be covered by the Vendor with no costs being passed along to the receiving District. Proper nutritional documentation, (i.e. Product Specifications and Product Formulation Statements) will also be provided before or when the substituted item is delivered.

The lists of proposal items have been vetted through the District's menu item review process and have been determined acceptable in regards to nutrient content including saturated fat, sodium, and trans fat. Any substituted proposal item must include nutrient content documentation (Product Formulation Statement) that also contains specific information that includes saturated fat, sodium, and trans fat.

- 5. ORDER LIABILITY: Any cost incurred by an order issued against this Contract by Rialto Unified School District shall be the sole responsibility of the Participating School District placing the order.
- 6. <u>DISCOUNTS</u>: The Vendor must identify the amount of each discount, rebate and other applicable credit on bills and invoices presented to the school food authority of the Rialto USD Child Nutrition for payment, and individually identify the amount as a discount, rebate, or in the case of other applicable credits, the nature of the credit.
- 7. <u>INVOICES</u>: Invoices shall be submitted in triplicate to Rialto Unified School District Child Nutrition and shall contain the following information: purchase order number, item number, item description, quantity, unit price, extended totals, and applicable discounts for items delivered. Failure to enter the above information on the invoice may cause delay in payment. Payment shall be made on partial deliveries accepted by the Rialto Unified School District. Payment terms are Net 30.
- 8. <u>DELIVERY SCHEDULE</u>: Delivery of all items shall commence immediately and be completed within the given time frames after receipt of a district order. Failure to complete deliveries on time shall be considered sufficient cause for default.
- 9. <u>DELIVERY INSTRUCTIONS</u>: All items ordered under this agreement shall be delivered as FOB destination to twenty-nine (29) site locations during specified delivery window. <u>Keys are not available</u>.
- 10. GOVERNING LAW AND VENUE: In the event of litigation, the RFP, Proposal specifications, and related matters shall be governed by and construed in accordance with the laws of the State of California. Venue shall be with the appropriate state or federal court located in San Bernardino County.
- 11. <u>ATTORNEY'S FEES:</u> If suit is brought by either party pursuant to this Contract to enforce any of its terms (including all component parts of the contract documents), and the District prevails in such suit, the Vendor shall pay all litigation costs and expenses incurred by the District, including attorneys' fees, court costs, expert witness fees and investigation expenses.

12. <u>INSURANCE</u>: Without limiting Vendor's indemnification of Rialto USD Child Nutrition, Proposer shall provide and maintain at its own expense during the term of the resulting Contract, the following program(s) of insurance covering its operations hereunder. Such insurance shall be provided by the insurer(s) satisfactory to the District and evidence of such program(s) satisfactory to each participating school district shall be delivered to Rialto Unified School District on or before the effective date of Contract. Such evidence shall specifically identify the Contract and shall express conditions that the District is to be given at least thirty (30) days written notice in advance of any modification or cancellation of any policy of insurance.

A) Liability

Such insurance shall be primary to and not contributing with any other insurance maintained Rialto USD Child Nutrition, and shall name the District as an individual issuer, and shall include but not be limited to:

1) Comprehensive General Liability Insurance

Endorsed for Premises-Operations, Products/Completed Operations, Contractual, Broad Form Property Damage, and Personal Injury with a combined single limit of two million dollars (\$2,000,000.00) per occurrence, five million dollars (\$5,000,000.00) aggregate.

2) Comprehensive Automobile Liability

Endorsed for all owned, hired and non-owned vehicles with a combined single limit of two million dollars (\$2,000,000.00) per occurrence.

B) Worker's Compensation

A program of Workers Compensation Insurance in an amount and form to meet all applicable requirements of the Labor Code of the State of California, and which specifically covers all persons providing services on behalf of Vendor and all risks to such persons under this Contract.

C) Product Liability

Vendor must maintain liability insurance including extended coverage for product liability in an amount not less than one million dollars (\$1,000,000.00) combined single limit and provide each participating district with a certificate evidencing insurance and specifying that coverage shall not be canceled or modified without thirty (30) days prior notice.

- 13. <u>CAL-OSHA</u>: The Vendor certifies by delivery, that all items furnished under this Contract meet or exceed the applicable CAL-OSHA requirements.
- 14. <u>DEFAULT:</u> Any Participating School District may, by written notice of default to the Vendor, terminate the whole or any part of their order under this Contract if:
 - A. The Vendor fails to make delivery within the time specified herein.

OR

B. The products received are of inferior quality and not the same as specified or shown at the sampling. These items shall be returned at the Vendor's cost. Vendor shall arrange for pick up after written notification by the District. Vendor shall be responsible for cost of replacement if District deems it necessary to procure suitable substitute items from supplier other than original

Vendor. District may hold inferior items until delivery of suitable items and cost of replacement are suitably concluded.

OR

C. If Vendor fails or neglects to furnish or deliver any equipment, products, materials or services at the prices quoted, or at the times and places stated, or otherwise fails to comply with the terms of this Contract in its entirety, the District reserves the right to purchase the items herein specified from another source, after providing the Vendor with a three (3) calendar day — (72 hours), unless a different cure period has been accepted by the District. All additional costs or expenses incurred by reason of the failure of the Vendor, as above stated, shall be paid by Vendor and his sureties, if any. The price paid by the District to other sources shall be considered the prevailing market price at the time such purchase is made. In the event that Rialto USD Child Nutrition terminates their orders in whole or in part, they may procure supplies or services similar to those terminated from other sources, and the Vendor shall be liable to the District for any additional costs for such similar supplies or services.

The Vendor shall not be liable for any excess cost if the failure to perform under this Contract arises out of causes beyond their control. Such causes may include, but are not restricted to: acts of God or the public enemy, acts of the Government, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, or unusually severe weather. Normal price increases as a result of market or economic trends are excluded from these sections. The Vendor shall be required to deliver all supplies or services under this Contract once circumstances and causes beyond their control cease. The Contract is not terminated as a result of occurrence of causes beyond Vendor control.

15. <u>DETERMINATION OF APPLICABILITY OF EMPLOYEE FINGERPRINT REQUIREMENTS OF CONTRACTORS AND INDEPENDENT CONTRACT CONSULTANTS</u>

Background

Pursuant to Education Code Section 45125.1, it is necessary to Rialto USD to determine whether a contractor or independent contract consultant must have its employees fingerprinted and screened for criminal records. Except for emergency or exceptional situations, California Education Code Section 45125.1 requires entities contracting with local educational agencies "ensure that any employee who interacts with pupils, outside of the intermediate supervision and control of the pupil's parent or guardian or a school employee has a valid criminal records summary as described in Section 44237"

The District has made an initial determination that the timing, location, and frequency of the delivery requirements to meet the terms of this Contract are such that Vendor employees will not have access to pupils outside of the immediate supervision and control of parents, guardians, or District employees.

By accepting the award of this Contract, the Vendor agrees to the terms outlined herein and will take such action as is necessary to ensure the Vendor employee(s) have no unsupervised contact with students at the delivery sites pursuant to Education Code section 45125.1. Failure to comply with this requirement will be satisfactory cause for termination of the Contract.

16. <u>INSPECTION AND ACCEPTANCE</u>: Inspection and acceptance of all items shall be at destination. All substitutions shall have prior approval. Items found to be defective or not in accordance with the

bid specifications shall be replaced by the Vendor at no additional cost to the participating district. Failure to replace items not meeting bid specifications and/or defective items shall be considered sufficient cause for default.

All items provided under this bid shall meet or exceed the bid specifications and shall comply with all Federal and California State laws governing their production, handling, and processing. Inspection shall be the responsibility of the school district and unacceptable products will be rejected by the district and replaced by the bidder at no cost to the school district. Crushed, damaged, or unacceptable temperature products will be rejected. Failure to replace said items shall be considered sufficient cause for default.

Rialto USD Child Nutrition staff reserves the right to inspect operation facilities without notice.

- 17. EXCUSE FOR NONPERFORMANCE FORCE MAJEURE CLAUSE: The Vendor shall be excused from performance hereunder during the time and to the extent that it is prevented from obtaining, delivering, or performing in the customary manner by act of God, fire, strike, partial or total interruption of, loss or shortage of transportation facilities, lockout, commandeering of raw materials, products, plants, or facilities by the government, when satisfactory evidence thereof is presented to the other party providing it is satisfactorily established that the nonperformance is not due to the fault or negligence of the party not performing.
- 18. PERFORMANCE BOND: On May 5, 2016, the U.S. Department of Agriculture (USDA) issued Policy Memorandum SP 35-2016: This memo clarifies that the bonding requirements in 2 CFR, Section 200.325 apply only to subcontracts of construction or facility improvement contracts exceeding the Simplified Acquisition Threshold. (District may have stricter bonding requirements than required by the USDA, if so, a Performance Bond may be required by the lead district for the Bid) It is the Bidder's responsibility to confirm and meet individual Participating School Districts performance bond requirements in order to be awarded the Contract.
- 19. PREVAILING LAW: In the event of any conflict or ambiguity between a) the Instructions to Bidders, General Conditions, Specifications, Agreement, or any other document forming a part of this RFP, and b) state or federal law or regulations, the latter shall prevail. Additionally, all equipment to be supplied or services to be performed under the bid proposal shall conform to all applicable requirements of local, state and federal law.
- 20. ENERGY POLICY AND CONSERVATION ACT: Vendor will comply with the requirements of 42 USC § 6201 which contain policies relating to energy efficiency that are defined in the state energy conservation plan issued in compliance with the law.
- **21.** <u>INDEPENDENT CONTRACTORS:</u> While providing the items included herein, the Vendor is an independent contractor and not officer, employee, or agent of any participating school district.
- 22. <u>NON-DISCRIMINATION ENDORSEMENT:</u> Vendor agrees to comply with all applicable Federal and California State anti-discrimination laws and regulations and agrees not to unlawfully discriminate against any prospective or active employee engaged in the work on basis of race, color, age, ancestry, national origin, sex, religious creed, marital status, or physical or mental disability, or sexual orientation or any other category protected by the law, including but not limited to, the

California Fair Employment Practice Act, beginning with Labor Code Section 1410, and Labor Code Section 1735. In addition, the Vendor agrees to require compliance by all subcontractors employed. Vendor is required to sign the Equal Opportunity Act endorsement included with this Contract.

- 23. <u>ASSIGNMENT OF THE AGREEMENT</u>: No Contract awarded under this Proposal shall be assigned without the prior written approval of the District.
- 24. <u>LIABILITY/COPYRIGHT</u>: The Proposer shall hold Rialto School District, their officers, agents, servants, and employees harmless from liability of any nature or kind whatsoever on account of use by the publisher or author, manufacturer, or agent, or any copyrighted composition, secret process, patented, or unpatented invention, or appliance furnished or used under this Proposal.
- 25. <u>DELIVERY FREQUENCY</u>: All prices shall be quoted FOB destination. Destination shall be the District placing the order. No additional fees shall be charged for small orders. <u>All deliveries shall be accompanied by a printed receipt</u>. Purchase order number shall appear on all delivery receipts and invoices. All costs for delivery, drayage, insurance, freight or the packing of the said articles is to be borne by the Proposer.
- 26. QUANTITIES: Quantities shown are estimated usages of Rialto Unified School District, Child Nutrition for the proposal period. Rialto USD, Child Nutrition reserves the right to purchase more or less of the units specified. Rialto Unified School District, Child Nutrition will order in quantities best suited to their needs and storage facilities. Prices shall be firm for Rialto USD Child Nutrition and shall not increase or include shipping or any additional handling fees for Rialto Unified School District ordering in small quantities. These quantities are not guaranteed by Rialto USD Child Nutrition but are included for information only.
- 27. "PIGGYBACK" CLAUSE: Rialto USD Child Nutrition will <u>not allow</u> Piggyback for the term of the Contract and any mutually agreed extensions pursuant to this proposal.
- 28. <u>PROPOSERS DISCLOSURE INFORMATION:</u> All disclosure, certification and non-collusion form or affidavits contained in this proposal must be completed and submitted prior to the final award.
- 29. <u>PROPOSER CRITERIA FORM</u>: The Proposer Criteria Form must be completed and submitted with the proposal.

30. <u>CERTIFICATIONS:</u>

- **A.** The VENDOR shall comply with Title VI of the Civil Rights Act of 1964, as amended; USDA regulations implementing Title IX of the Education Amendments; Section 504 of the Rehabilitation Act of 1973; and any additions or amendments to any of these regulations.
- **B.** The VENDOR shall comply with all applicable standards, orders, or regulations issued, including:


